COVID-19 Protocol

Health and Exposure Screening

- Parents/Guardians must check their Scouts for [COVID-19 symptoms](#) prior to leaving for a Scout meeting. Refer to the symptom screening chart below.
- Please keep your child at home if he/she is feeling ill or has COVID-19 symptoms, even if symptoms are very mild, and get tested for COVID-19.
- Leaders should call in sick and stay home if they have COVID-19 symptoms and get tested for COVID-19.
- Anyone with COVID-19 symptoms should not return for in-person meetings until they have met the [CDPH criteria](#) to discontinue home isolation:
 - At least 10 days have passed since symptoms first appeared, AND
 - At least 24 hours have passed with no fever (without use of fever-reducing medications), AND
 - Other symptoms have improved.
- Notify your unit leader if your child or anyone in your household has been exposed to anyone who developed symptoms of COVID-19.
- If any leader or Scout exhibits, or reports experiencing 1 or more symptoms of COVID-19 during our activities, they will be directed to an isolation area until they can be transported home or to a healthcare facility, as soon as practicable.

Face Coverings

- All leaders, Scouts and family members who enter Yerba Buena High School (our meeting location) are required to wear face masks for the duration of our meeting.

Hygiene

- All hands will be washed/sanitized frequently, including as soon as Scouts arrive at the meeting, after coughing/sneezing, after handling any shared items, and before and after using the restroom.
- Limit personal items from being brought to the meeting and only bring what is necessary.

Stable Groups and Distancing

- Scouting units will stay together and minimize mixing with other units. Each unit should stay in their designated meeting area as much as possible.
- Adult leaders should stay with their units as much as possible.
- Units should maintain physical distancing between Scouts and between leaders and Scouts.
- Parents should do their best to maintain physical distancing among each other and from Scout units during meetings.

COVID-19 Case Response and Reporting

- If a confirmed COVID-19 case is reported to our group, we will:
 - Take the appropriate steps to notify Santa Clara County within 24 hours as instructed by our council
 - Exclude the Scout/leader from meetings for 10 days from symptom onset date, or 10 days from specimen collection date if asymptomatic
 - Identify and notify all families of Scouts
 - Recommend COVID-19 testing
